- Foreign trainers** holders of a foreign authorisation to train race horses, wishing to work and live in France on a regular basis (except during « meeting » periods, pursuant to the new regulation introduced this year) : they must first inform their individual racing Authorities that delivered their authorisations to train. They must also apply to the SETF Stewards for an individual autorisation to train. To this end, and to be granted such Authorisations to train, they must fulfil – as the case may be - the conditions contained in the Rules of Trot racing (« Codes des Courses au Trot» in French). These formalities shall be carried out before applying for a training yard or boxes at Grosbois.

Meeting periods : concerning **foreign trainers**, only professional trainers are authorised to apply for boxes, with the exception of foreign owners employing trainers on a wage-earning permanent basis.

Required documents : Extrait SIRENE (= SIRENE Registry Form) for an individual working in his/ her own right. Extrait K-Bis (= K-Bis commercial Registry Form) for a racing Stable.
