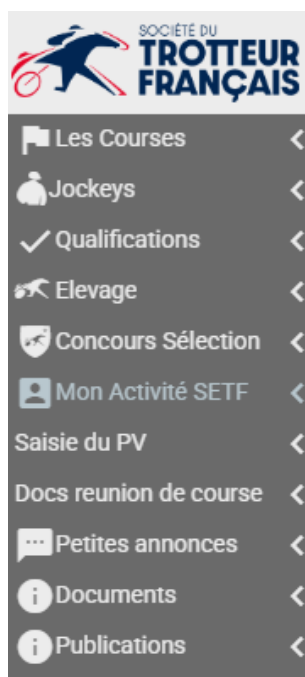


Procedure to obtain a racecourse access card

(SETF membership card)

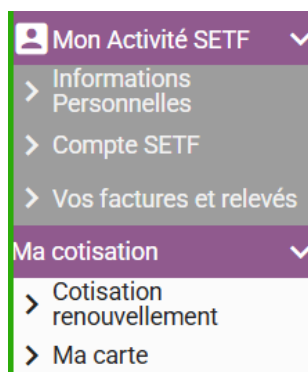
1. Access your INFONET profile :

Go to “Mon activité SETF” (My SETF activity).



2. Click on “Ma cotisation” and then on “Cotisation renouvellement" (Renewal subscription):


=> Pay your membership fee if you have not already done so.



3. Download an ID photo:

- Go to "Ma carte" (*My card*).
- If no photo is registered (or if it is out of date), upload a new passport photo.

Uploading the photo activates your card.

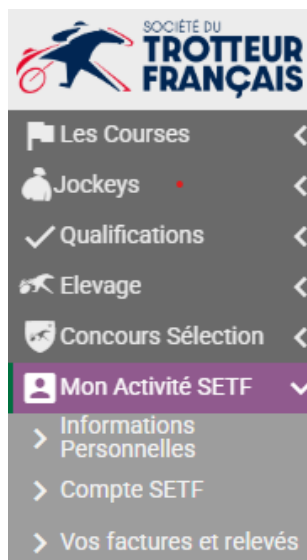

4. Check your postal address:

- Go to "Mon activité SETF" (*My SETF activity*),
- Then Personal Information > Addresses,
- Update your address if necessary



5. Reminder : If the “Ma cotisation” (My contribution) section does not yet appear in your INFONET space, this means that your rights have not yet been opened.

This section will appear automatically as soon as racing activity is detected with a horse in which you hold shares and for which the racing career declaration or association declaration has been validated.

You will be informed by message as soon as you are eligible.

• **Reminder (BO of 02/01/2025):**

Pursuant to the provisions of article 4 of the SETF Articles of Association (amended on April 13, 2023) and article 2 of decree no. 97-456 of May 5, 1997, **owners, breeders, trainers and jockeys/drivers meeting the following criteria are members of the Société d'Encouragement à l'Élevage du Trotteur Français (SETF):**

- **Owners** : Individuals or legal entities who, in 2024 or 2025, have raced at least one horse under their colors in a public race governed by the French Trotting Code, held in association or leased, and trained in France.
- **Breeders** : Individuals or legal entities having bred, in full ownership or co-ownership, a product born and bred in France, having taken part in a race in 2024 or 2025.
- **Trainers and jockeys/drivers**: Persons holding professional licenses issued for the year 2025.

The annual membership fee for 2025 has been set at €40 including VAT

The amount for an apprentice or a lad-jockey is €10

(Decision of the Board of Directors on November 14, 2024).

• **Carte MEMBRE**

Membership cards are **reserved for people who meet the conditions defined in the SETF statutes** (*modified on April 13, 2023*), in accordance with the provisions of decree no. 97-456 of May 5, 1997, and having been active in 2024 or 2025. Membership fees must be up to date for cards to be issued.

• **Carte PRIVILEGE**

For **those who do not meet the above conditions**, a **Privilege 2025 card, giving access to the racecourses**, is available at a price of **€50 including tax**. This card can be requested by any owner or lender of a horse trained in France, having participated in a public race in 2024 or 2025.

Payment of the fee and request for the card are made via the INFONET server.
